Want to Know Your Rights As an LGBTO Student?

GLAD's Got Your Back.

Knowing Your Rights is the First Step to Empowering Yourself.



All Public School Students Have the Right:

- To be safe in school without being bullied or harassed by other students, teachers, or staff.
- To be protected from discrimination based on your sexual orientation or gender identity.
- To access information about LGBTQ subjects, including educational websites.
- To free speech and expression, including the right to express ideas respectfully that may offend others, and to disagree with others.
- To dress and present yourself in a manner consistent with your gender identity.

Under the Massachusetts Department of Elementary and Secondary Education (DESE) Guidance, Transgender and Gender Non-Conforming Students Have the Right:

- To be called by their chosen names and pronouns.
- To be allowed access to bathrooms and locker rooms in accordance with their gender identity.
- To participate in gender-based activities like athletics according to their gender identity.
- To keep their medical records private.



All Public and Some Private School Students Have the Right:

- To be protected from discrimination or harassment based on your sex or HIV status.
- To be protected from sexual harassment.
- To be protected from bullying, defined as "any repeated written, verbal, electronic, or physical acts that:
- (1) cause you physical or emotional harm;
- (2) damage your property;
- (3) create a hostile school environment;
- (4) infringe on your rights; or
- (5) disrupt your education."
- To form a Gay/Straight Alliance (GSA) that gets treated the same as every other non-curricular group. This means equal funding, access to facilities, and the ability to choose your group's name.



What You Can Do if You're Being Harassed, Bullied or Discriminated Against:

- Tell somebody. If you have understanding friends, parents, teachers, or counselors, use them as a support system.
- Keep notes on what's happening (and record who, when, where, and how).
- Get a copy of your school's policies on student conduct and discipline. It might be in your student handbook or on the school website. You can also talk to your guidance counselor or school administator.
- Report it to the person designated in your school's policy. Make your report in writing or electronically so you can prove you made it.

 Under the Massachussets anti-bullying law, all teachers and staff must report any bullying they know about and must take action to investigate it, stop it, and prevent it from happening again. The school also must inform your parents and the parents of the bully, but you have the right to ask them not to 'out' you on your LGBTQ or HIV status.

Outside School, You Have the Right:

- To be protected from discrimination based on your sex, gender identity, sexual orientation or HIV status in employment, housing, credit and public accommodations (like restaurants or stores, though your access to a restroom based on your gender identity is not assured).
- To give your own consent to get tested for HIV without your parents' permission, if you think you may have been exposed to it.
- To keep your HIV status private. Under MA law, healthcare providers can't release HIV test results without your consent unless they feel your life is in danger, in which case they must notify your parents or guardians.
- To report to the police anyone in or out of school who physically harms you, threatens you or vandalizes your property.
